UH Manoa Tailgating Policies

- 1. Tailgating permitted only with purchase of a Tailgating Pass. Each purchaser shall be considered the Pass Holder.
- 2. Tailgating Pass covers one parking space for one Tailgate Vehicle within the Tailgating Area.
- 3. Tailgating Pass will be displayed as to be easily visible through the front windshield.
- 4. The Tailgating Area will consist of several parking areas along Correa Road in the upper UH Manoa campus as noted on the attached and may be subject to change. No tailgating permitted in the UH Manoa lower campus parking structure.
- 5. Pass Holder will park in a Tailgating Space as directed by parking personnel. No saving of spaces will be permitted.
- 6. All Tailgating Activity will be limited to the Tailgating Area and each Tailgating Party will limit their Tailgating Activity to the Tailgating Space occupied by their Tailgate Vehicle.
- 7. Each Pass Holder shall be responsible for the conduct of every person who is a member of their Tailgating Party and who arrive in the Tailgate Vehicle with the Tailgate Pass holder.
- 8. Tailgating Area will be open at least 4 hours prior to the scheduled kickoff.
- 9. Tailgating Area will be closed 30 minutes prior to the scheduled kickoff and all persons must vacate the Tailgating Area by this Tailgating Deadline.
- 10. No Tailgating Activity permitted after Tailgating Deadline, including after the football game.
- 11. Each Pass Holder is to ensure that everyone in their Tailgating Party complies with the applicable laws, UH policies, the Athletics Guest Code of Conduct and the Tailgating Policies, including vacating the Tailgating Area by the Tailgating Deadline.
- 12. Each Pass Holder to ensure all items used are repacked in Tailgate Vehicle prior to leaving.
- 13. Each Pass Holder to ensure Tailgating Space cleaned and restored to same condition upon arrival.
- 14. Each Pass Holder responsible for the cost of repairing any damage caused by Tailgating Party.
- 15. No interfering with the rights of others to enjoy Tailgating Activity or use their Tailgating Space.
- 16. No obstructing the use of adjacent Tailgating Spaces or areas others are entitled to use.
- 17. No alcoholic beverage consumption in Tailgating Area and no public display of impairment or intoxication.
- 18. No smoking, smoking devices or tobacco products
- 19. No illegal drugs or illegal use of controlled substances or other intoxicants.
- 20. No fighting or physical assault.
- 21. No unruly or inconsiderate behavior.
- 22. No destruction, damage or defacing of UH property or the property of others.
- 23. No open fires or flames or any grilling using charcoals, wood or similar combustible materials, provided propane grilling meeting minimum conditions will be permitted.
- 24. No use of grills within tents, canopies, covered areas or under any physical buildings/structures.
- 25. No deep fryers or any oil-based cooking equipment or utensils.
- 26. No tent poles or stakes may be driven into the ground and tents cannot be anchored to any buildings/structures or intrude into or cover adjacent Tailgating Spaces without permission.
- 27. No littering or improper disposal of trash or waste
- 28. No drones, model aircraft or vehicles, kites, or any other remote-controlled aircraft, vehicles or other objects or tethered flying objects.
- 29. No motorized vehicles such as motorcycles, mopeds, golf carts, all-terrain vehicles, three wheeled vehicles, trikes, bicycles, e-bikes, motorized scooters, motorized skateboards
- 30. No recreational play, including ball playing, Frisbee tossing, football tossing, bike riding, skateboarding, and rollerblading.
- 31. No sponsorship or advertising banners or signs without prior UH written approval;
- 32. No animals, except service animals or as approved by UH in advance;
- 33. No concerts, public performances, contests, and live broadcasting without prior UH approval.

- 34. No excessively loud music or amplified sound that can be heard more than 5 feet away from the amplifying unit or registering more than 80 decibels, including TVs and mobile phones/devices.
- 35. No soliciting, hawking, selling, passing out literature handouts or giving away free items.
- 36. No weapons, fireworks, ammunition, or any explosives or similar materials.
- 37. All persons shall only use restrooms in designated UH buildings or portable restrooms.
- 38. All persons shall comply with directions of law enforcement, security and UH personnel.
- 39. All UH students must comply with the Student Code of Conduct as contained in UH Executive Policy EP 7.208 (Systemwide Student Code of Conduct). Students violating the Student Conduct Code will be subject to discipline and consequences consistent with the Student Code of Conduct.
- 40. Any violation of the laws, UH Policies, the Athletic Guest Conduct Code and/or the Tailgating Policies, including the failure to vacate the Tailgating Area by no later than the Tailgating Deadline, may result in loss of parking and/or tailgating privileges, denied access to one or more football games, physical removal from and denied future access to the football stadium or the UH Manoa campus, detention, arrest, and/or possible loss of individual football game or season tickets.
